Q: At which location do you need the one PRI?

A: **Central Office at 1226 E State St, Salem, OH 44460**

Q: With regards to your point-to-points between the schools and your dedicated internet access, are you currently under contract with an ITC for these services? If so, when will your contract expire?

A: **Quote based on the information provided on the 470. The narrative requested quotes for 3 scenarios: Internet only, Transport only and Bundled Internet/Transport. The narrative also provides service addresses. Service would need to start July 1, 2016. If we elect to contract the service, the contract term should begin July 1, 2016.**

Q: I have qualified your area, but would like to check all locations for serviceability. Let me do the work for you. For each location I need the address (Street and City Name), # of lines you require. Please use the following table as a template. (Estimated numbers are OK, add more rows as needed)

CATEGORY 2

Q: Will submissions with recertified product be accepted?

A: **Only new equipment will be accepted.**

Q: Will partial submissions be accepted (e.g. for HP products only, not Meraki)?

A: **All proposals of equivalent products will be considered.**

Q: Is the wireless access part of the project new installation, refresh of a current network or adding to an existing network. If new, is cabling needed?

A: **Adding to an existing network. The 470 narrative states that no cabling is required for the WAPs.**

Q: With regards to the 80 WAPs needed for WIFI, do you have equipment that you will be using and just need pricing to manage your existing equipment, or are you looking for new equipment and a fully-managed solution of the WIFI?

A: **If your question relates to Managed Internal Broadband Service (MIBS), we require pricing to manage existing, district-owned equipment (up to 174 WAPs).**

Q: Is the HP 1920 switch on the attached "RFP" supposed to be a HP 2920 switch?

A: **It is listed correctly as HP 1920.**
